transportation

If ARTIST and PURCHASER agrees ARTIST and contracted players are arriving by air, PURCHASER shall, at their sole cost and expense, provide GROUND TRANSPORTATION for ARTIST and entourage, plus luggage and equipment, etc. between airport, hotel, concert venue and return to airport upon departure.

accommodations

If PURCHASER is providing HOTEL ACCOMMODATIONS, the following are required:

- One NON-SMOKING room with single bed
- Meal allowances, as needed

hospitality

- 4 Cans Sugar Free Red Bull (must be sugar free – artist is diabetic)
- 4 Bottles Water
- 1 Bottle of Ciroc Coconut or Ciroc Regular
- Minimum 10 Admissions

technical requirements

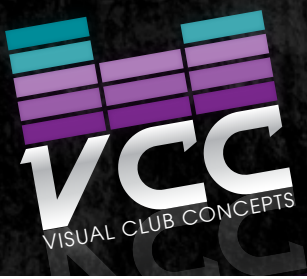
PURCHASER shall provide the following equipment at his sole expense and at no cost to the ARTIST:

1. STAGE
 - a. If a stage is used, it must be a minimum of 10ft. (10') wide and 6ft. (6') deep and 1ft. (1') high. The stage must be flat, level, and free of irregularities.
2. SOUND
 - a. TWO (2) loud stage monitors setup in STEREO w/ DJ CONTROLLABLE VOLUME.
 - b. DJM-800 Pioneer Mixer or DJM-900 Nexus *All knobs, faders, effects and inputs/outputs must be in 100% working order
 - c. ONE (1) working microphone to be sound checked for DJ use (prior to DJ arrival)
3. LIGHTING
 - a. Sufficient lighting in the DJ area to utilizing equipment and music.

4. DJ SET UP

- a. 30" Working Space For Library & Hard Drives *DJ Table must be at minimum of 32" H
- b. Laptop Stand Above Mixer

Purchaser agrees to the following safety conditions:

- Equipment (CDJ's, Mixer & Tables) must be situated away from any bar or beverage areas
- Artist area must not be accessible to the general public from the front, sides and, especially, from behind
- During the entire span of the artist's performance, there will be no persons inside the booth besides authorized staff or artist's representatives/friends

Purchaser agrees to the following additional terms:

- Artist reserves the right to play whatever music DJ wishes to play unless a specific music/song request is provided and agreed upon prior to signing of agreement
- Artist will be bringing a few pieces of equipment to be hooked up and sound checked prior to event
- Artist requires at least 10 guests allowed to attend at any time during the event
- Artist requires at least 1 (one) VIP parking space. This parking space may be used by anyone designated by artist.
